1. Council voted to approve the Consent Agenda engross which includes the Work Session Minutes of July 13, 2020, Public Hearing Minutes, July 13, 2020 and Regular Scheduled Meeting Minutes, July 13, 2020.
2. Council voted to approve the Final Reading of Ordinance #2020-0727-02 for Charter Amendment to change toe vote to remove a city manager from five affirmative votes of members of the City Council to four affirmative votes of members of the City Council.
3. Council voted to approve the Final Reading of Ordinance #2020-0727-03 to Add Ringgold Pavilion at Depot Square as an Authorized Venue to Use Preferred Caterers List.
4. Council voted to approve the Final Reading of Ordinance #2020-0727-01 to Amend the Employee Handbook to Add Section Captioned "Electronic Tracking".
5. Council voted to approve recommending the Ringgold Convention and Visitors Bureau to place the following at the Great Locomotive Chase Park: Sign denoting the name of park and joint venture of Catoosa County, City of Ringgold and DDA and place neglected completion plaque on stone pedestal at rail viewing platform denoting completion date and members of Catoosa County Board of Commissioners, May and City Council, Sen. Jeff Mullis, city managers, Department of Corrections and any other entities which should be included should be placed accordingly.
6. Council voted to approve CTI's Task Order No. R20-02 to evaluate storm drainage of the ditch and pipes extending from Hwy 41 and Old County Road, along the rear of the residences on the west side of Meadow Lane to Ridge St.

7. Council voted to approve CTI's Task Order No. R20-03 to design approximately 800 linear feet of sidewalks, curb and storm drainage inlets/pipes on the west side of Meadow Lane from the existing sidewalk on Old County Road to the existing sidewalk at the intersection of Ridge St. and Meadow Lane.
8. Council voted to authorize Mayor Millwood to sign Resolution and Agreement for Expenditure of Municipal Excise Tax Proceeds.
9. Council voted to approve the Resolution of the City of Ringgold supporting the application and participation in the Georgia Initiative for Community Housing 2021 Cohort; committing necessary staff time and resources; authorizing execution of necessary documents; and for other related purposes.
10. Council voted to approve the Ratification of Jennifer Jones as Chief of Police.
11. Council voted to stop charging a refundable deposit fee in the amount of \$25.00 for the rental of the Pavilion at Little Children's Park and to charge a flat fee of \$25.00 for each time slot.
