- 1. Council voted to approve the Consent Agenda engross which includes the Work Session Minutes October 19, 2021, and Regular Scheduled Meeting Minutes October 19, 2021.
- 2. Council voted to approve signage being placed at the intersection of Nashville Street and Depot Street "No Trucks", a bollard being placed just past the parking lot, and a sign at Cotter and Depot instructing trucks to turn left. Shaw is also installing a one-way gate to allow trucks to turn around by going around their building and to come out on Cotter and Emerson.
- 3. Council voted to approve the request of James L. Young and Dennis Young to subdivide the property into 2 lots. The property is located at Tax Map 38A, Parcel 112.
- 4. Council voted to approve the request of Leap Land Development, Inc. for a variance to reduce the rear setback from an approved 10 feet to 6 ½ feet and to construct a metal building in a C-2 Commercial zone. The property is located at Tax Map 37C, Parcel 2.

- 6. Council voted to approve the request of Mountain View Acquisition of Chattanooga, LLC for a variance of the Zoning Ordinance of the City of Ringgold to use metal panels on a building in a C-2 zone.
- 7. Council voted to approve the request of Anthony Samuel Faustine and Judy Faustine for a variance of the Zoning Ordinance of the City of Ringgold to reduce the required front setback of 40 feet to 20 feet 8 inches. The property is located at Tax Map R9, Parcel 32.
- 8. Council voted to approve moving forward with the Arts Vibrant Communities Grant Agreement FY22 and allow Mayor Millwood to execute.

- 9. Council voted to approve placing a stone in Citizen's Park honoring veterans of all wars. The stone will be provided by Daughters of American Revolution.
